- Lending Library: Suzette Cooley-Sanborn will take ownership of a lending library for the school. We need to create a new policy for this. Someone will need to make boxes.
- Yard Sale: The board had talked about having a yard sale to get rid of excess school supplies and hopefully make some room. Julie and Suzette will take ownership. It will be held on July 15, 2017 from 10:30 a.m. to 1:30 p.m. at the school. Cindy will post flyers.
- Savings to CD: Discussion on moving money from Savings to CDs. Suzette Cooley Sanborn made a motion to move \$100,000 from Citizens Bank Savings to First Community Savings. The motion was seconded by Jeff Liedel. Roll call vote: Ayes: Liedel, Maynard, Riker and Cooley-Sanborn. Nays: None. Absent: Antonetti. Motion carried. Jeff Liedel made a motion to move First Community Savings Account money into CDs; 2 (two) for \$50,000 into a 6 (six) month CD, and in 3 (three) months an additional 2 (two) for \$50,000 into a 6 (six) month CD, for a total of \$200,000. The motion was seconded by Julie Maynard. Roll call vote: Ayes: Liedel, Maynard, Riker and Cooley-Sanborn. Nays: None. Absent: Antonetti. Motion carried.
- Online Banking: Being investigated by Cindy Riker.
- Amended Budget for 2016-2017: Reviewed with the board.
- Proposed Budget for 2017-2018: Reviewed with the board. Recommendations noted.
- Public Meeting and Special Meeting: These budget meetings will be held on June 27th at 10 a.m. at the school. Cindy will post.
- School Repairs: We discussed the repairs that needed to be done to the school. Jeff Liedel made a motion for us to post a notice asking for bids to power wash, repair, seal and stain the exterior of the school. The motion was seconded by Suzette Cooley-Sanborn. All in favor. Motion carried. Cindy will post a notice with responses to be received the day before the next school board meeting.
- Business Services Consortium: The agreement with the EUPISD was reviewed. Julie Maynard made a
 motion to approve the 3 (three) year contract. The motion was seconded by Suzette Cooley-Sanborn.
 Roll call vote: Ayes: Liedel, Maynard, Riker and Cooley-Sanborn. Nays: None. Absent: Antonetti.
 Motion carried.
- Other: We discussed the Virtual Classes mentioned by Dan Reattoir during his visit last month. We need to look at Internet by TDS versus Verizon Hot Spot. Discussion on summer reading for Blake.

Financial Report:
